You and two of MTCC 1170's Directors have known for several months that I did not intend seeking re-election to the Board of Directors at MTCC 1170's AGM 2026.

Thus, I have two options. One would be to serve my term and allow MTCC 1170's owners to elect an unknown owner as replacement at AGM 2026.
