Resolution 250819R04: Parking Garage Drainage Piping Replacement

WHEREAS Building Sciences has provided "Bid Documents for Parking Garage Drain-

age Piping Replacement Prepared for Metropolitan Toronto Condominium Corporation No. 1170 Located as 7 King Street East Toronto, Ontario" ("Bid Documents") for MTCC 1170's parking garage floors 3, 4 and P1-P3 (inclusive); THEREFORE,

BE IT RESOLVED that the board of Directors of MTCC 1170 receives the analysis as information and approves its use for differentiating among competing bids for the remedial work that the Bid Documents describe; AND, FURTHER,

BE IT RESOLVED that MTCC 1170 directs Management, as might be necessary, to inform and assist Building Sciences in the bid-analysis process.

- (b) Discussion of changes in neighbourhood lighting:
- King Edward Hotel installed bright lights on west side, affecting MTCC 1170's east-facing units.
- Problem persists for several months, noticeable increase in brightness (change in light colour?)
- Affected units: floors 7-16, particularly 14-15

- Multiple attempts to resolve:
  - Direct contact with King Edward Hotel (no response)
  - 311 complaints filed by management
  - Residents advised to file individual 311 complaints
- Historical context: Previous lighting issues with other neighbours (e.g., fire escape) were resolved cooperatively

Management Office requested to draft and send notice to residents re: King Edward Hotel lights; instruct to report to 311 if affected.
